# The adaptation, retrofit and remodelling of a Listed Quaker House Friends Meeting House

The Quakers were formed by George Fox in 1652 and are responsible for key legislation in today's society.

The Lewes Meeting House was built in 1724 and is listed and located in a conservation area. It had been badly extended in the 50's and over subsequent years leading to poor thermal performance, noise problems, water ingression and issues with poor access.

Planning and Listing Building consent took many years, but the recent building work has seen this iconic building retrofitted, and extended to provide inclusive access with a hybrid heat pump system and other measures to secure a more sustainable future for the building.
